further to amend the Balochistan Local Government Ordinance, 2001.

WHEREAS, It is expedient further to amend the Balochistan Local Government

Ordinance, 2001 (NVED. for the purposes hereinatter appearing:

AND WHEREAS, — the President of Pakistan has, in consultation with Prime Minister, accorded sanction to the said amendments in the Balochistan Local Government Ordinance, 2001, in terms of clause (2) of Article 268 of the Constitution of Islamic

Republic of Pakistan, 1973,

AND WHERE AS, the Provincial Assembly is not in session and the Governor is satisfied that the circumstances exist which render it necessary to take immediate

action:

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, 1973, the Governor of

the Province of Balochistan is pleased to make and promulgate the following Ordinance:-

i Short title and commencement. (1) This Ordinance may be called the

Balochistan Local Government (Amendment) Ordinance, 2007.

(2) It shall come into force at once and shall be deemed to have taken effect

from 16<sup>th</sup> February, 2007.
