Preamble. WHEREAS it is expedient further to amend the Baluchistan

Local Government Ordinance, 1980 (II of 1980) for the purpose hereinafter appearing;

AND WHEREAS, the Governor is satisfied that circumstances : exist which render it necessary to take immediate action; pe NOW, THEREFORE, in exercise of the powers vested in him by Article 123 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 1 of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance:-

Short title and if (1) This Ordinance may be called the Baluchistan Local Government (Amendment) Ordinance, 1982. ge

(2) It shall come into force at once.

Local Council Service or an employee of a Local Council shall retire from service—

(i) on such date after he has completed twenty — five years of service qualifying for pension or other retirement benefits, as the Competent Authority may, in the public interest, direct; or

, (ii) where no such direction is given under clause (i), on the completion of the sixtieth years of his age.

EXPLANATION— In this Section “Competent Authority” Means the Appointing Authority or a person duly authorised by the Appointing Authority in that behalf, not being a

Person lower in rank than the holder of the post of Local Council Service or the employee of the Local Council

concerned. ”
