Preamble. WHEREAS it is expedient further to amend the  
Balochistan Local Government Ordinance, 1980, in the manner  
hereinafter appearing;

AND WHEREAS the Governor is satisfied that  
circumstances exist which render it necessary to take immediate  
action;

Article 128 of the Constitution of Islamic Republic of Pakistan,

Amendment of  
Section 139 of  
Ordinance II  
of 1980.

1973, the Governor of Balochistan is pleased to make and promulgate the following Ordinance :--

1. (1) This Ordinance may be called the Balochistan Local Government (Amendment) Ordinance, 1993.

@) ~\_ It shall come into force at once and shall be deemed to have taken effect on the 28th day of July, 1993.

2 In the Balochistan Local government Ordinance, 1980, in section 139,-

(a) after the words "a Local Council" twice appearing in sub-section (1), the words "or Local Councils" shall be inserted.

(b) after clause (d) of sub-section (1) the following new clause shall be inserted :--

(e) may mis-use and apply its funds visibly or invisibly, at the instance of its Chairman a member(s) to impair the holding of fair, free and impartial elections to the National or/and Provincial Assembly."

(c) the full stop appearing at the end of sub-section (3), shall be substituted with a colon and thereafter the following proviso shall be added :--

"Provided that no enquiry shall be held or caused to be held when action is taken under clause (e) of sub-section (1)."
