WHEREAS it is expedient further to amend the
Baluchistan Local Government Ordinance, 1980, in
the manner hereinafter appearing.

"It is hereby enacted as follows:-

1. (1) This Act may be called the Baluchistan Local
Government (Second Amendment) Act, 1986.

(4) {t shall come into force at once. and shall be deemed
to have taken effect on the 1st day of July 1980,

2. In the Baluchistan Local Government Ordinance,
1980, the existing section 8 shall be numbered as sub-
section (1) of that 'section and after sub-section (1),
as so numbered, the following new sub-sections shall
be added:- '

"5 The Government may, if it so desires, give
retrospective effect to any "notification issued under
this section. :

(3) Notwithstanding anything contained in "any law

for the time being in force, any tax, rate, toll or
.fees levied, charged, collected or realized before the

commencement of this Act shall be deemed to have

"been validly levied, charged, collected or realized,

as if this Act was in force on the day on which such
tax was levied, charged, collected or realized. ,

The Baluchistan Local Government (Amendment) Ordin-
ance, 1985 (XXII of 1985), is hereby repealed.
