Preamble. WHEREAS it is expedient further to amend the Baluchistan Local Government Ordinance, 1980 (II of 1980), for the purpose hereinafter appearing:
AND WHEREAS, the Government is satisfied that circumstances exist which render it necessary to take immediate action -

Now, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 1 of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance:—

Short title and 1. (1) This Ordinance may be called the Baluchistan Local Government (Second Amendment) Ordinance, 1982.

(2) It shall come into force at once and shall be deemed to have taken effect from 1.7.1980.

Amendment of 2. In the Baluchistan Local Government Ordinance, 1980 Section 3 of (II of 1980), hereinafter referred to as the said Ordinance, after Ordinance 1 of Clause (7) of section 3, the following new clause shall be added, 1980. namely

“(7-A) “Consumption” Means utilization of an article by

Causing change in its existing position and nature,

which may include conversion of a ship or any other

floating structure into its pieces, scrape and other

articles of similar nature, commonly known and styled

“@8 Ship breaking,” in the said Ordinance, after clause (c) of sub-section (1) of section 70, the following new clause shall be added, namely:-

Amendment of 3.

Section 70 of the Ordinance II

of 1980.

“(d) to recover a tax from any date even with retrospective effect.”
