Preamble. WHEREAS it is expedient further to amend the Baluchistan Local Government Ordinance, 1980 (il of 1980):

AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action:

NOW, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 4 of 1981). the Governor of Baluchisten is pleased to make and promulgate the following Ordinance:—

Short title 1. (1) This Ordinance may be called the Baluchisten and commence- Loca! Government (Second Amenéçrrent) Ordinance, ment. 1983.

(2) It shall be deemed to have taken effect en nd from 11th July, 1983.

Amendment of 2. In the Baluchistan Local Government Ordiner ce,

Section 21 of 1980, hereinafter referred to as the said Ordinance,

Amendment o . In the said Ordinance, in section 22, the section 22 of ‘fullstop ‘ appearing at the end of clause (f) shall be Ordinance ! substituted by a ‘colon’ and thereafter the following of 1980. proviso shall be added :—

“Provided that nothing herein contained shall apply to a person who is a member of the Federal or Provincial Cabinet or of Federal_or Provincia} Council or of any Co /Committee:

Provided further that notwithstanding anything contained in clause (f) of section 22, the Government may on its own motion or on a representation made to it, allow any person by an order in writing to be a candidate or a member.”
