NOW THEREFORE, in pursuance of Article 4 of the Provisional Constitution (Amendment) Order, 1999, (Chief Executive's Order No. 9 of 1999), and in exercise of all powers enabling him in that behalf, the Governor of Balochistan is pleased to make and- promulgate the following Ordinance:- Sey .

i (1) This Ordinance may be called the Balochistan Local Government Election (Third Amendment) Ordinance, 2001.
(2) It shall come into force at once.

a In the Balochistan Local Government Election Ordinance, 2000, hereinafter referred to as the said Ordinance, for section 9, the following shall be substituted:-

a Minority Seats. In a union where the population of minorities is in excess of ten percent of the total population of the

union, reserved seats for minority communities mentioned in the preceding section shall be allocated in the manner prescribed by the Government".
