AN
ORDINANCE

to amend the Balochistan Local Government Election Ordinance, 2000 (VI of 2000).

WHEREAS it is expedient to amend the Balochistan Local Government Election Ordinance, 2000, in the manner hereafter appearing;

AND WHEREAS, in pursuance of the Proclamation of emergency dated 14th October, 1999 and under Article 3 (2) of the Provisional Constitution Order No, | of 1999, dated 14th October, 1999, the Governor of a province is to act on the instructions of the Chief Executive;

AND WHEREAS, under Article 4 of the Provisional Constitution (Amendment) Order NO. 9 of 1999, the Governor of a province may, on the instructions of the Chief Executive of Pakistan, issue and promulgate an Ordinance;

'D WHEREAS, under the Local Government Elections Order, 2000 (No. 8 of 2000, she Chief Executive of Pakistan has been pleased to empower the Chief Election Commissioner to conduct local government elections in the Provinces,

AND WHEREAS, the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW THEREFORE, in exercise of the aforesaid powers and all other powers enabling him in this behalf, the Governor of the Balochistan, on the instructions of the - Chief Executive of Pakistan, is pleased to make and promulgate the following Ordinance:-

1. n m ment- (1) This Ordinance may be called the Balochistan Local Government Elections (Amendment) Ordinance, 2000

(2) It shall come into force at once

2. mendm of ion f inan Lo In the Balochistan Local Government Election Ordinance, 2000, hereinafter referred to as the said Ordinance, in sub clause (i) of clause (b) of sub section (1) of Section 3, after the word "Muaziaat", the commas and the words " or, in case of areas where settlement of land under the Land Revenue Law has not taken place, one or more population census villages", shall be iINnse Ae

3. Amendment of Section 6 of Ordinance VI of : 99- In the said Ordinance, in clause (b) of sub section (2) of section 6, after the word "workers" the words "subject to a minimum of one seat" shall be inserted

ft A m f Se 7 of Ordin Vic 2000— In the said Ordinance. in clause (b) of sub section (2) of section 7, after the word "and Wo: kers", the words "subject to a minimum of one seat " shall be inserted

5. Amendment of Section 9 of Ordinance of 2000- in the said Ordinance, for section 9, the following shall be substituted, namely: -

"9. Special Minority seats. In a local area where the population of minorities is in excess of ten percent of the total population of that area, the seats mentioned in the preceding sections shall be allocated in such manner as the Government may determine."

6 Amendment of Section 13 of Ordinance VI of 2000- In the said Ordinance, in

Section 13,-

(i) for sub-section (2), the following shall be substituted. namely:-

"(2) The Union shall be the multi-member ward for election of members of a Union Council, other than Union Nazim and Naib Union Nazim.":

(ii) sub section (3) shall be omitted
