Preamble. WHEREAS it is expedient to provide for the control the movement of Marble and Coal minerals from Baluchistan to other Provinces of the State;

AND WHEREAS the Governor is satisfied that circumstances exist which render it 'Necessary to take immediate action; iy

_ NOW, THEREFORE, in pursuance of the Proclamation of the fifth day of July, 1977 read with the Laws (Continuance in Force) Order, 1977 (CMLA Order No. 1 of 1977) and in exercise of all Powers enabling him in:that behalf, the. Govepnpre sof: \Baluchistan is pleased th" make and Promulgate the following 'Ordinance:-

Short title 1. (1) This Ordinance may be called the Baluchistan Marble! -- extent and _ and Coal Minerals (Control of Movement) Ordinance, 1978. commencement. : . ' oh

(2) It shall extend to the whole Province of Baluchistan -" except the Tribal Areas.

(3) ## shall come into force 'at once.

—_ 2.1n this Ordinance.unlegs there is anything repugant Definitions. in the subject or context;-

(a) "Government" means the Government of Baluchistan.

(b) "Licensing Authority" means the Joint. Disector'of Mineral Development. Government of Baluchistan.

3. No person or Company shall ,be allowed to transport... either by road ax rail: Coal-or Matble from the'Proviice of ° Baluchistan tq other.Provines: except on @rahdari, issued in this behalf,-by the Licensing Authority.

4. Any person, Company may apply to the Licensing . Authority for grant of rahdari-on a Form prescribed by the Government.

5. The' Government:may..hy notification im 'the: gazette prescribe the manrier in which the Licensing Authority may issue rahdari before despatch of Coal, Marble by road/ rail from the Province of Baluchistan for the quantity of . minerals purchased and intended for despatch by the

purchaser or agent on submission of an application. ;

6. The permit/rahdari shall be issued immediately by the Licensing Authority on demand to the individual/agency on his production of relevant material signifying the sources and quantity of minerals Purchased.

7. The individual/agency shall submit to the Licensing Authority a monthly return on the prescribed Form showing the quantity of minerals purchased and despatched by him, before 7th of each ensuing month,

8. If any individual/agency fails to comply with the provisions of this Ordinance or the rules made thereunder, he or it, as the case may be, shall be liable to be fined upto Rs. 5,000/- (Rupees five thousand) for each violation and the Coal or Marble shall be liable to confiscation in favour of the Government by the Licensing Authority. The fine imposed under this section shall be recoverable as arrears of land revenue.

9. The Licensing Authority may delegate all or any of its powers to any Officer of Grade-17 in the Directorate of Mineral Development Baluchistan.

10. The Government may make rules for carrying out the purpose of this Ordinance.
