Official Transport for Chairman of Committee,

A Member who holds the office of a Chairman of a Committee of Assembly. other than that of a Select Committee or a Special Committee shall be entitled to the use of not more than one official car regardless of his entitlement to have an official car in any other capacity, and where he avails himself of this facility. he shall not be entitled to receive the conveyance allowance:

(i) only one car shall be provided to a chairman of a (**) Committee during the whole term of his office:

(ii) A Chairman of a (**) Committee shall be allowed "five thousand

rupees" per month as POL. charges.
