JOINT CADRE (DISSOLUTION)

ORDINANCE, 1971
(Balochistan Ordinance XIII of 1971)

[30% September, 1971]

An Ordinance to provide for the dissolution of the
Balochistan Ministerial (English) Service joint Cadre and
allocation of the members of the said Joint Cadre to different
departments of the Provincial Government.

WHEREAS it is expedient to provide for the dissolution
of the Balochistan Ministerial (English) Service Joint Cadre and
allocation of the members of the said Joint Cadre to different
Departments of the Provincial Government.

NOW, THEREFORE, in pursuance of the Martial law
Proclamation of 25" March, 1969, read with the Provisional
Constitution Order and in exercise of all powers enabling him
in that behalf, the Governor of Balochistan is pleased to make
and promulgate the following Ordinance: —

1. () This Ordinance may be called the Balochistan
Ministerial (English) Service Joint Cadre (Dissolution)
Ordinance, 1971.

(2) It shall come into force at once.

2. In this Ordinance, unless the context otherwise requires,
the following expressions shall have the meanings hereby
respectively assigned to them: —

(a) "Government" means the Government of
Balochistan; and

(b) "Joint Cadre" means the Balochistan Ministerial (English) Service Joint Cadre, constituted for the former Balochistan Administration.

3. qd) The Balochistan Ministerial (English) Service Joint Cadre shall be deemed to have been dissolved on and with effect from 30th September, 1965.

This Ordinance was promulgated by the Governor of Balochistan on 23rd September, 1971; published in the Balochistan Gazette (Extraordinary) No. 24, dated 30th September, 1971; saved by Article 281 of the Interim Constitution of the Islamic Republic of Pakistan (1972); and validated by Fed. Act LXIII of 1975.

2 Spelling of the word "Baluchistan", wherever it appears in this regulation, is corrected by insertion of letter "o" instead of "u";

(2) Members of the Joint Cadre named in column 2 of the Schedule shall with effect from 30th September, 1965, be deemed to have been allocated to the Departments of Government mentioned against them in column 3 thereof.

(3) A person allocated to a Department of Government under the provisions of subsection (2) shall with effect from the date of his allocation be governed by the service rules applicable to other staff of that Department holding a corresponding rank or post.

(4) The seniority of persons allocated to different Departments under the provisions of sub-section (2), in the various grades of posts or services in such Departments, shall be determined with reference to the date of their continuous appointment in the grade:

Provided that a person confirmed in a grade will rank senior to a person who is officiating in the grade:

Provided further that where two persons have been appointed to a grade on the same date, the person older in age will be given seniority over the other.

Explanation. — For the purposes of this sub-section, the expression "grade" shall be deemed to consist of a number of posts of the same category in the same class of Service carrying the same duties and responsibilities and in a common or comparable scale of pay.

4. Any order passed by the Commissioner, Quetta Division on or after the first day of October, 1965, in respect of the members of the Joint Cadre relating to their confirmation, promotion, transfer, or allocation to a Department shall be deemed to be void and of no effect.

5. Notwithstanding anything contained in section 3: —

(a) Government may, if it is satisfied that the allocation of a person to a Department as provided in the Schedule has caused or is likely to cause hardship to such person or any other person who was a member of the Joint Cadre, or for any other sufficient cause, by order in

writing, direct such person to be allocated to any other Department or service under Government;

(b) Government may by order require any person who has been allocated to a Department under

the provisions of clause (a) or sub section (2) of section 3, to serve in any place or post in Pakistan, whether under the Central or the Provincial Government or in or under a public statutory Corporation or to serve under any person or under any association or body of persons, whether incorporated or not, appointed or established by or under the authority of the Central or the Provincial Government or to serve abroad, and the person to whom such order is directed shall comply with it with all necessary speed.
