WHEREAS it is expedient to ide for the establishment of the Model Residential ondary Schools in Baluchistan to promote education;

AND WHRBAS tho Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the wers conferred by Article 128 of the Constitution, road with © 2 of the Provisional Constitution Order, 1981 (C.M.L.A. Order No. 1 of 1981), the Governor of Baluchistan is pleased to make and promulgate the following Ordinance :-

1 (1) This Ordinance may be called the Baluchistan Mode} Residential Secondary Schools Ordinance, 1983.

(g) to lay down procedure for admission, promotion and removal of students from School;

(h) to institute scholarships and stipends;

(i) to set up an Executive Committee and such other Standing Committee as may be necessary',

9. The Governor or his nominee shall be the Controlling Authority of Board.

10. (1) The Controlling Authority shall have power to cause an inspection to be made by such person as it may direct, of the offices, activities and funds of, and all examinations conducted by the Board and to cause an inquiry to be made in like manner in respect of any matter concerning the School.

(2) The Controlling Authority shall communicate to the Board the findings of the inspection or inquiry, and advise the Board to take such action and within such period as may be specified.

(3) The Board shall report to the Controlling Authority the action it proposes to take on such communication.

(4) Where the Board does not, within the specified time, submit its report as required by sub-section (3), or the Controlling Authority is not satisfied with the action taken or proposed to be taken, the Controlling Authority may, after considering any explanation given

by the Board, issue such directions as it thinks fit, and the Board shall comply with such directions.

(5) The Controlling Authority , from time to time, direct the Board to conduct its affairs and thaloon its functions in such manner as it may apecify.

16. The accounts of the Board shall be audited every year by the Convenor, hereinafter referred to as the auditor, =

(2) The Board shall, at the time of audit, produce all accounts, registers, documents and other papers which may be required by the auditor to assist him in his investigation,

(3) The Board shall, as soon as possible after the end of each financial year, submit to the Governor the annual statement of the account of the Board duly audited, together with the report of the auditor and its comments on the report,

16. The Board shall submit to the Governor for his approval a statement of estimated receipt and expenditure in respect of the next financial year at such time and in such manner as may be prescribed, and shall give effect to any modification made therein by the Governor.

17. As soon as, may be after the close of every financial year but not later than the last day of September next following, the Board shall submit to Governor for approval of report on the conduct of the affairs of the Board for that year.

(2) The Governor may require the Board to furnish with:- ;

(a) any return, statement, estimate, statistics or other information or report regarding any matter under the control of the Board,

(b) a copy of any document in the charge of the Board, and the Board shall comply with every such requisition.

public servants within the meaning of section 21 of the Pakistan Penal Code (XLV of 1860).
