Preamble WHEREAS, it is expedient to amend the Balochistan Motor Vehicles Ordinance, 1965 (ordinance XIX of 1965
in the manner hereinafter appearing.

It is hereby enacted as follows:-

Short title 1 (1) This Act may be called the Balochistan Motor and commencement Vehicles (Amendment) Act, 2022.

(2) It shall come into force at once

be substituted.
