WHEREAS, it is expedient to amend the Balochistan Motor Vehicles Ordinance, 1965 (Ordinance No. XIX of 1965), in the manner hereinafter appearing;

It is hereby enacted as follows:-

(1) This Act may be called the Balochistan Motor Vehicles (Amendment) Act, 2017.

(2) It shall come into force at once.

2 In the Balochistan Motor Vehicles Ordinance, 1965 (W.P. Ordinance No. XIX of 1965), hereinafter referred to as the said Act, in section 116-A after the words "charge on" the words "spot any person committing in his view an offence

mentioned in" shall be substituted.

3. In the said Act, for "The Twelfth Schedule" the following shall be substituted, namely:-
