The Balochistan Motor Vehicles (Amendment) Bill 2022, (Bill No.06 of 2022), having been passed by the Provincial Assembly of Balochistan on 26<sup>th</sup> February, 2022 and assented to by the Governor Balochistan, on 07 March, 2022 is hereby published as an Act of the Balochistan Provincial Assembly.

further to amend the Balochistan motor vehicles  
ordinance, 1965(ordinance XIX of 1965)

Preamble. WHEREAS it is expedient to amend the Balochistan  
Motor Vehicles Ordinance, 1965 (Ordinance XIX of  
1965) in the manner hereinafter appearing;

It is hereby enacted as follows:-

Short title and 1. (1) This Act may be called the Balochistan Motor  
Commencement. Vehicles (Amendment) Act, 2022.

(2) It shall come into force at once.

Amendment of 2. In the Balochistan Motor Vehicles Ordinance, 1965

Section 2, hereinafter referred to as the said Ordinance, in section  
Ordinance No.XIX 2, in clause (15), after the words "defect or disability",  
of 1965. the words "including differently disabled persons with

hearing impairment" shall be inserted.

Amendment of 3. In the said Ordinance, in section 7, in sub section

Section 7, (5), in the proviso, after clause (b), the following shall be  
Ordinance No.XIX added:-  
of 1965. (c) "the applicant with hearing impairment

having up to 40 DB hearing loss shall wear  
hearing aids and in case the hearing loss  
exceeds 40 DB, the applicant shall use  
assistive technology devices or means as per  
description vehicles of special type  
mentioned in the Form A\K of First Schedule."

Amendment in

(d) the person who will take the driving test should know sign language or should be assisted by a person who knows sign language.

(€) No license fee shall be charged from such person;

Provided that the vehicles of such persons shall attach mandatory stickers on their vehicles, as may be prescribed.”
