The Balochistan Motor vehicles (Amendment) Bill, 2025 (Bill No. 14 of 2025), having been passed by the Provincial Assembly of Balochistan on 10<sup>th</sup> March, 2025 and assented to by the Governor Balochistan, on 14<sup>th</sup> March, 2025 is hereby published as an Act of the Balochistan Provincial Assembly.

further to amend the Provincial Motor Vehicles Ordinance, 1965 (Ordinance xix of 1965)

Preamble. WHEREAS, it is expedient to amend the Provincial Motor Vehicle Ordinance, 1965 (Ordinance No. xix of 1965) in the manner hereinafter appearing;

Short title and 1. (1) This Act may be called the Balochistan Motor Vehicles (Amendment)

Commencement. Act, 2025.

(2) It shall come into force at once.

Amendment of 2. In the Provincial Motor Vehicles Ordinance 1965 (Ordinance XIX of 1965)

Section 76. hereinafter referred to as the said Ordinance, in Section 76, in sub-section (2), after the words "tyres" the words "and is not exceeding the axle load as mentioned in Fifteenth Schedule" shall be inserted.

Amendment of 3. In the said Ordinance, in Section 107, for the words "one hundred" the words "twenty-five hundred" and for the words "five hundred" the words "five thousand" shall be respectively substituted.

Amendment in 4. In the said Ordinance, in twelfth schedule under headings "PENALTY the Twelfth RATES" "MOVING VIOLATIONS" ,—  
Schedule.
