Preamble.

WHEREAS it is expedient to further amend the Baluchistan Motor Vehicles Taxation Act, 1958 (Act XXXII of 1958) in its application to the Province of Baluchistan in the manner hereinafter appearing;

AND WHEREAS the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of the - fifth day of July, 1977 read with the Laws (Continuance in Force) Order, ° 1977, (CMLA ORDER NO. I of 1977). and in exercise of the powers\* enabling him in that behalf, the Governor of Baluchistan is pleased to make and promulgate the following Ordinance:—

Short title and 1. (1). This Ordinance may be called the Baluchistan Motor Vehicles commencement. Taxation (Amendment) Ordinance, 1979. :
