1°! Breamble. \_ . WHEREAS it is expedient to amend — the Baluchistan Orphanages (Supervision and Control) Ordinance 1978 (V of 1978), for the purpose hereinafter appearing; ‘

“6. (1) If for any reason, the Chairman becomes unable to perform his duties temporarily, the senior most official member shall act as chairman till such time the Chairman resumes his duties.

(2) In case the office of Secretary falls temporarily vacant, or if for any reason the Secretary becomes unable to perform his duties temporarily, the Chairman shall nominate any of the official members Or an officer of the Board to perform the duties of the Secretary during the subsistence of the vacancy.”
