Preamble. WHEREAS it is expedient to amend the Baluchistan _Orphanges (Supervision and Control} Ordinance, 1978, for the purpose hereinafter appearing;

AND WHEREAS the Governor is satisfied that circumstances exist which render

it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by Article 128 Of the Constitution, read with Article 2 of the Provisional Constitution Order, 1981 (C.MLL.A. Order No.1 of 1981), the Governor of Baluchistan is pleased to make and promulgate - following Ordinance :-

Shorttitle and 1. (1) This Ordinance may called the Baluchistan Orphanges (Supervision and commencement. Control) (Amendment) Ordinance, 1984. .

(2) It shall come into force at once.

Amendment of 2. In the Baluchistan Orphanges (Supervision and Control!) Ordinance, 1978, section 11 of hereinafter referred to as the said Ordinance, afterclause (b) of sub -section'(2) of section Ordinance V 11, the semi colonandthe word «,-and occurring at the end shall be substituted by a of 1978. colon and thereafter the following proviso shall be added, namely; -

"Provided that the money collected through Zakat and Fitrah shall be Spent in accordance with the Injunctions of the Holy Quran and the Sunnah of the Holy-

Prophet.+

Amendment of Sf In the said Ordinance, in section 18, the full stop occurring at the end section 18 of Shall be substituted by a colon and thereafter the following proviso shall be added, erdinace V namely:- of 1978,

"Provided that no appeal shall be decided unless the appellant has been afforded an opportunity of being heard."
