(1) Notwithstanding anything contained in any existing law including Acts, Ordinances, Orders, Rules, Notifications and Regulations, the provisions of this Act shall take effect and all appeals, reviews or revision petitions or any other case pending before the Board of Revenue, the Revenue Commissioner or a Deputy Commissioner or any other authority in pursuance of the Act shall stand transferred to the respective Commissioners and may be disposed of by them according to Law,
