WHEREAS it is expedient to amend the-Baluchistan, Preventic
of Gambling Ordinance, 1978%in the manner hefinafter appearing.

it is hereby. enacted as follows :—

1. (1) This-Act may. e-talled the Baluchistan Prevention-of Gamb-
ling (Amendment):Act, 4985.

(2) It shall come into force at once.

2. In the Baluchistan Prevention of Gambling Ordinance .978
hereinafter referred to as the said Ordinance, in ‘section 5, for the
words “one year” and “five hundred rupees” the words “three years”

and “five thousand rupees”. shall be substituted; respectively.

3. In the said Ordinance, in section 6, for the words “two years”
and ‘one. thousand rupees” the words “five years” and “seven tho-
usand rupees” shall be substituted, respectively.

4. In the said Ordinance,,in section 7, for the words “three years”
and “two thousand rupees” the words “seven years” and “ten thou-
sand rupees” shall be substituted, respectively.

5. In the said Ordinance, section 11, shall be omitted.
6. Any order passed, action taken or any decision, made after the lapse of the Baluchistan Prevention of Gambling (Amendment) Ordinance, - 1985 (XX of 1985), under the provision of the said Ordinance shall be deemed to have been validly passed, taken or made, as if this Act was in force on the day on which such order was passed action taken or decision made.
