further to amend the Balochistan Public Procurement Regulatory
Authority Act, 2009 (Act VIII of 2009).

Preamble. WHEREAS, it is expedient to
further amend the Balochistan Public
Procurement Regulatory Authority Act,
2009 (Act VIII of 2009), in the manner
hereinafter appearing;

It is hereby enacted as follows;

Short Title and L (1) This Act may be called the
Commencement. Balochistan Public Procurement
Regulatory Authority (Amendment) Act,
2022.

(2) It shall come into force at
once.

Amendment of 2) In the Balochistan Public
Section 2, Act Procurement Regulatory Authority
VIII of 2009. Act, 2009 (Act VIII of 2009), hereinafter

referred to as the said Act, in section 2,
after clause (d) the following new
clauses shall be inserted, namely:-

"(d-a), Electronic Public
Procurement" means use of
information and communication
technology in conducting public

procurement.

Amendment in
Section 5, Act
VIII of 2009.

“(d-b) Electronic Public Procurement System” means an electronic public procurement system (E-PPS) accessible through single web portal/ web link, from where and through which procuring agencies and_ suppliers perform all or some of _ their procurement related functions including publishing of annual procurement plans, advertisement of procurement opportunities, preparation of bidding documents, request for quotation, reverse auctions, framework agreements, dynamic purchasing, tender submission, tender opening, tender evaluation, contract award

notices, contract management, invoicing & payments, procurement management information functions, monitoring and any other functions as prescribed;”

3; In the said Act, in Section 5,

(a). in sub-section (2), for clause “g-b”, the following shall be substituted, namely:- 5

“(g-b) maintenance of e-PPS which may enable the procuring. agencies and suppliers to perform public procurement and/or Electronic public procurement related activities in accordance with the rules framed under this Act,” , and

(b). after clause g-b, as so amended above, the following new clause shall be added, namely:-

“(g-c) charge fee from registered procuring agencies and suppliers in lieu of services in accordance with the instructions issued by the Authority,”
