AND WHEREAS | the Provincial Assombly of Balochistan stand suspended' in pursuance of the Proclamation of Emergency of the fourteenth day of October, 1999., and the Governor is satisfied that circumstances exist which render it necessary to take immediate action ; _

NOW THEREFORE in pursuance of Article 4 of the Provisio Constitution (Amendment) Order, 1999 (Chief Exceutive's Order No™~ 1999). and in exercise -of all powers enabling him in that behalf. the Governor of Balochistan is pleased to make and promulgate the following Ordinance:-

I. (1) This Ordinance may be called the Balochistan Prohibition on Use and Sale of Polythene Bags Ordinance, 2001.

(2) It extends to the whole of Province of Balochistan except Tribal Areas.

(3) It shall come into force at once.

2 In this Ordinance. unless the context otherwise requires the following expressions shall have the meaning hereby respectively assigned to them, that is to sav-

(a) "Factory" means any premises where the polvthene bags are made and produced:

(b) "Person" includes a shopkeepers. factory owners. hawkers and others: =

(c) "Polythene bags" means a leading thermoplastic processed from? polythene granules.

a No person shall import, make. sale and offer any kind of catable and non eatable goods in any kind of polythene bags in the Province of Balochistan.

4 Any person who contravenes the provisions of svetion 3. shall be liable to imprisonment for a term which may extend to 3 months or with fine upto fifty thousand rupees or with both

Offence to be 5. Notwithstanding anything contained in the Code of Criminal
cognizable and Procedure, 1898, an offence punishable under this Ordinance shall be
bailable, cognizable and bailable within the meaning of the said Code
