WHEREAS it is expedient to amend the Baluchistan
Provincial Assembly Members (Allowances and Privileges)
Act, 1972, for the purpose hereinafter appearing;

It is hereby enacted as follows :—

1. This Act may be called the Baluchistan Provincial Assembly
Members (Allowances and Privileges) (Amendment) Act, 1974,

2, In clause (3) of section 2 of the Baluchistan Provincia
Assembly Members (Allowances and Privileges) Act, 1972 (Act
No. III of 1972), hereinafter called the said Act, the commas and
the words beginning with 'but does not' and ending with
"is entitled"? shall be omitted.

3, In section 3 of the said Act, for the words, figures and
brackets 'Subject to Article 7 of the Members of Assemblies
(Allowances and Privileges) Order, 1972 (P.O, No, 7 of 1972)
each" the word "Each" shall be substituted, F

4. — In section 8 of the said Act, after the words "any subsequent
financial year"? and before the word "or", the words and commas
"or, in the case of a Minister, Speaker or Deputy Speaker, from
the date he ceases to hold that office', shall be inserted,

5. Notwithstanding anything contained in section 8 of the
said Act, a Minister of the Provincial Gove ronment, who ceased to
hold office on 15+2-1973 mav elect, within a period of thirty days
from the commencement ot - his Act, to receive from 1502-1973
to 30.6-1973 a consolidated allowance of rupees eight hundred
per month in lieu of the compensatory allowance mentioned in

sub-section (1) of section 3 of the said Act and the benefits and privileges mentioned in sections 6 and 7 thereof,
