further to amend the Balochistan Provincial Employees  
Group Insurance Act, 2009, (Act No. X of 2009).

WHEREAS, it is expedient further to, amend the  
Balochistan Provincial Employees Group Insurance Act, 2009  
(Act No. X of 2009) in the manner and for the purpose hereinafter  
appearing; °

It is hereby enacted as follows:

1. (1) This Act may be called the Balochistan Provincial

Employees Group Insurance (Amendment) Act, 2011.

(2) It shall come into force at once.

2s In the Balochistan Provincial Employees Group Insurance  
Act, 2009 (Act No. X of 2009) hereinafter referred as the said Act,  
in section 2, after clause (k) the following new clause shall be  
added, namely:-

“(l) Schedule” means the schedule appended to this Act.”

36 In the said Act, in section 4, in sub-section (1). in clauses (e), (f) and (g) the word “Additional” appearing before the word “Secretary” shall be omitted.

4, In the said Act, in section 14, for the words “of the schedule” the words, figure and sign “and column 3 of the Schedule respectively,” shall be substituted.

5. In the said Act, for the Existing schedule the following shall be Substituted, namely:-

**"SCHEDULE**

**GROUP INSURANCE**

The rate of contribution to the Provincial Employees

Group Insurance Fund and the amount of sum assured to be

paid to the employées or to the family of an employee, shall

be as under:-
