'> THE BALUCHISTAN PUBLIC FINANCE MANAGEMENT (AMENDMENT)

ACT 2021, ACT No. XVI of 2021.

ACT

to amend the Baluchistan Public Finance Management Act, 2020 enacted through Baluchistan Finance Act, 2020 (Act No. 1 of 2020).

Preamble. WHEREAS, it is expedient to amend the Baluchistan Public Finance Management Act, 2020 enacted through Baluchistan Finance Act, 2020 (Act No. 1 of 2020), for the purposes

It is hereby enacted as follows: -

Short title and 1. (1) This Act may be called the Baluchistan Public Finance Management (Amendment) Act, 2021.

(2) It shall come into force at once.

shall be inserted, namely: -

'(da) "Budget Grant or Grant" means the amount granted or deemed to have been

granted by the Provincial Assembly in respect of a demand for grant;”

(db) “Charged Expenditure or Expenditure Charged upon the Provincial Consolidated Fund” means such items of expenditure as are enumerated in Article 121 of the Constitution and are not submitted to vote in the Provincial Assembly under Article 122 (1) of the Constitution;”

(b) after clause (g), the following new Clause shall be inserted, namely: -

“(ga) “Demand for Grant” means a proposal made to the Provincial Assembly on the recommendation of the Government for withdrawal of certain sum out of Provincial Consolidated Fund for expenditure which is granted or deemed to have been granted under Article 122, of the Constitution;”

(gb) “Development Project” means a project or scheme or program involving developmental expenditure;”

(gc) “Pre-Audit” means and include a process whereby the concerned Accounts Office or the officer as stated in section 32, ensures that all the applicable laws relating to any certain transaction have been complied with, before the occurrence of transaction, by the concerned Principal Accounting Officer (PAO) or any of its authorized sub-ordinate officer, to whom such financial powers have been delegated from the Government;”

(ed) “Provincial Assembly” means the Provincial Assembly of Balochistan;”

(c) in clause (0), after the word “rules”, the words “or regulations” shall be inserted;

(d) in clause (q), the words “and includes moneys, other than Provincial Consolidated Fund, received by or on behalf of the Government or a Public Entity; moneys received by or deposited with the Supreme Court or any other court established; and moneys received by a Public Entity as a trust account, conditional grant, contribution or a donation from the general public or public servants, or from a foreign donor agency Or organization and is payable on demand or fulfilment of an obligation on the part of the payee or the beneficiary, as the case may be” shall be omitted;

(e) after clause (t), the following new clauses shall be inserted, namely: -

“(ta) “Regulations” means the regulations framed under this Act and the rules made

oe thereunder;

(tb) “Rules” means the rules made under this Act;

(tc) “Schedule of Authorized Expenditure” means the Schedule prepared following consideration by the Provincial Assembly of the Annual or Supplementary or Excess Budget Statement in respect of a financial year and authenticated by the Chief Minister by his signature under Article 123, of the Constitution;”

(f) after clause (w), the following new clause shall be inserted, namely: -

“(wa) “Technical Approval” means approval accorded by the competent forum to a PC-I / PC-II which are compliant with the standards and procedures set by the
