"WHEREAS it is expedient to repeal and, with certain modifications, re-enact the Baluchistan Public Service Commission Act, 1974 (Act IV of 1974).

AND WHEREAS the Governor of Baluchistan is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977 (CMLA Order No. 1 of 1977), and in exercise of all powers enabling him; in that behalf, the Governor of Baluchistan is pleased to make and a' :
Igat the following Ordinance :—

Short title and Commencement :- (1) This Ordinance may be called : "the Baluchistan public Service Commission Ordinance, 1978.'

It shall come into force at once.
