to further amend the Balochistan Sea Fisheries Ordinance, 1971 (Ordinance IX of 1971).

Preamble. Whereas, it is expedient to further amend the Balochistan Sea Fisheries Ordinance (Ordinance IX of 1971), in the manner hereinafter appearing;

It is hereby enacted as follows: -

Short title and 1. (1) This Act may be called the Balochistan Sea Fisheries Commencement. (Amendment) Act, 2022.

(2) It shall come into force at once.
