WHEREAS it is expedient: to establish a Students Welfare Fund for the Students. of the Province of Baluchistan for the purpose thereafter appearing:

AND WHEREAS, the Governor is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance' of the Proclamation of the fifth day of July, 1977, read with the Laws (Continuance in Force) Order, 1977 (C.M.LA.

Order No. | of 1977), and in exercise of all powers

enabling himin that behalf, the Governor of Baluchistan is pleased to make and promulgate the following Ordinance :- :

1. (1) This Ordinance may be called the Baluchistan Students Weifare Fund Ordinance, 1979."

(2) It shall come into force at once.

2. In this Ordinance, unless there is anything repugnant in the subject or context,-

(a) 'Board' means the Provincial Board Constituted by the Government under this Ordinance- ~
ance:

(b) "Chairman" means. the Chairman of. the Board;

(c) "Fund" means the funds.created under this Ordinance;

(d) "Government" means the Government of Baluchistan;

(e) 'Local Fund Audit' means the Local Fund | Audit as provided in the Baluchistan Local Government Act, 1975; ;

(f) "Member" means the member of the Board;

(g) "Ordinance" means. the Baluchistan Students Welfare Fund Ordinance, 1979;

(h) "Rules" means the rules framed under the Provisions of this Ordinance;

(i), "Students" means a Student studying in a

School/College/University run by the Government.

Provincial 3. (1) There shall be created a fund in the name of Fund. Provincial Fund for the Welfare of the Students.

(2) The Funds shall be raised in the manner provided under the rules.

Organization 4. (1) There shall be created a Board in the name of the Board. e Student Welfare Board with its Headquarters at Quetta.

(2) The Board shall consist of the following official and non-official members :-

(i) Senior Member, Board of Revenue, Baluchistan. i

(ii) Secretary Health, Government of Baluchistan.

(iii) Secretary Finance, Government of Baluchistan. '

(iv) Secretary Education, Government of Baluchistan.

(v) There shall be three non-official members to be nominated by the Government and notified in the official Gazette from amongst the public and philanthropists.

(3) The Senior Member, Board of Revenue,

~ Baluchistan and the Secretary Education, Government of

Baluchistan, shall respectively, be the Chairman and Secretary of the Board.

Functions of 5. (1) The Board shall be responsible for the operation of the Board. e collection and arrangement of the affairs of the funds, .

(2) The Board shall provide financial assistance to Students in distress particularly for medical treatment.

(3) The Board shall encourage and subsidize sports amongst the students. :

(4) The Board shall provide financial aid to the

students individually or collectively or in any other manner as it deems fit. .

Audit. 6. The fund shall be auditable by the Local Fund Audit.
Power to 7. The Government or the Board, if so empowered

make Rules. by the Government, may make rules for carrying out the
purposes of this Ordinance. :
