PART-I GENERAL.

1. Short title and commencement. (1) These rules may be called the
Balochistan Tehsildari Departmental Examination Rules, 1983.

(2) They shall come into force at once.

2. Definitions. In these rules, unless the context otherwise requires the

5. Authority for conducting examination. The examination shall be
conducted by the commission.

6. Procedure for appearance in the examination. (1) The candidate who

intend to appear in the examination shall submit their applications through
such authority within such time and in such manner and from as may be
prescribed from time to time by the Commission.

(2) The candidate intending to appear in the examination shall indicate
their intention/medium at the time of submission of their applications under
sub-rule (1). Only such candidates shall be allowed to appear in the
examination.

7. Syllabus. (1) - There shall be, combined examination for Assistant
Commissioner and Tehsildars i.e. the papers for the Tehsildari examination
shall be the same as for the Assistant Commissioners, but the candidates
intending to appear for this examination only shall not be required to answer

Paper on Jail, or to appear in the paper on Treasury.

8, Authority to grant grace marks, The Chairman of the Commission

may, at his discretion, grant grace marks in special cases at 4 percent of the marks obtained by the candidate in each Paper in which he has failed to prevent hardship to an individual,

9. Qualifying Standard. The minimum number of marks for passing the

examination each subject/paper shall be forty percent of the minimum marks allocated to that subject/paper.

10. Failures, A candidate who fails to secure the mini8mum number of marks prescribed under rule 9 in any subject/paper may, subject to the provisions of rule 4 appear in that subject/paper it is subsequent examination,

11. Publication of result, The result of candidates who have passed the examination shall be notified and published in the official Gazette by the Commission. The marks obtained by the candidate shall also be indicated in

the result.

12. Permission to consult books. (I) . The papers to be answered with the

aid of reference books shall be Criminal Law papers I & II, Civil Law, 1 and Local Government. Only the bare Acts will be
