WHEREAS. it is expedient to amend the Baluchistan Waqf Properties Ordinance, 1979, in the manner hereinafter appearing.

It is hereby enacted as follows:—

1. (1) This Act may be called the Baluchistan Waqf Properties (Amendment) Act, 1985.

(2) It shall come into force at once and shall be deemed to have taken effect on the 1st day of December, 1984.

2. In the Baluchistan Waqf Properties Ordinance, 1979, hereinafter referred to as the said Ordinance, after section S, the following new section shall be inserted: —

“S—A. Administrator, Deputy Administrator. & Officer to be. Muslim:— No person shall be appointed as an Administrator, Deputy Administrator or Officer under this Ordinance unless he is a Muslim and possesses such qualifications as may be prescribed.”

3. In the said Ordinance, in section 7, after sub-section (2), the following new sub-section shall be inserted:—

“(3) The notification issued under sub-section (1), shall be served upon the management or the Mutawali, as the case may be, and a copy thereof shall be affixed on some conspicuous place of the property referred to in the notification.”

4, In the said Ordinance, in section 16 :—

(a) in the beginning before the words “Government may” the words and’ comma “Subject. to the provision of sub-section (2) of section 15,” shall be added.

(b) the yyy stop appearing at the end of section 16, shall be substituted by a colon and thereafter the following proviso shall be added:—

“Provided that the sale proceeds of the property shall not be used for any purpose unless the main purpose of the waqf is served and satisfied”.

5. Anything done, action taken, order passed, or any -decision made after the lapse of the Baluchistan Waqf Properties (Amendment) Ordinance, 1985 (XV of 1985), under the i t the said Ordinance shall be deemed to have be taken, passed or made, as if this Act wi i which such thing was done, action taken, order passed or sion made.
