WHEREAS it is expedient to amend the Baluchistan  
Water Users Associations Ordinance, 1981, in the manner  
hereinafter appearing:

It is hereby enacted as follows:-

1. (1) This Act may be called the Baluchistan Water  
Users Associations (Amendment) Act, 1986.

to have taken effect on the 1st day of December, 1984.

2. In the Baluchistan Water Users Associations Ordin-  
ance, 1981, in section 6 :-

(a) in sub-section (7), the full-stop appearing at  
the end shall be substituted by a coloh and thereafter  
the following proviso shall be added:—

"Provided that no order in appeal shall be made  
against any person unless he has been given an  
opportunity of being heard."

(b) after sub-section (9), for the figure and full-  
stop "10! the bracket and figure "(10)" shall be  
substituted.

3. Any order passed, action taken or any decision  
made after the lapse of the Baluchistan Water Users  
Associations (Amendment) Ordinance, 1985 (XXI\_ of  
1985), under the. provisions of the said Ordinance  
shall be deemed to have been validly passed, taken,  
or made, as if this Act was in force on the day on  
which such order was passed, action taken or decision  
made. .
