(CHARGED EXPENDITURE)  
ORDINANCE, 1969

(West Pakistan Ordinance XLI of 1969)

[24"November, 1969]

An Ordinance to declare the expenditure relating to  
privy purses of Rulers of former States incorporated in the  
Province of 7[Balochistan] to be a charge on the Provincial  
Consolidated Fund.

WHEREAS it is expedient to declare the expenditure  
relating to privy purses of Rulers of former States incorporated  
in the Province of \*[Balochistan] to be a charge on the  
Provincial Consolidated Fund;

NOW, THEREFORE, in pursuance of the Martial Law  
Proclamation of 25" March, 1969, read with the Provisional  
Constitution Order, and in exercise of all powers enabling him  
in that behalf, the Governor of West Pakistan is pleased to make  
and promulgate the following Ordinance:—

1. () This Ordinance may be called the [Balochistan]  
Privy Purses (Charged Expenditure) Ordinance, 1969.

(2) It shall come into force at once.

2. Any sum paid by the '[Federal] Government as privy  
purses to the Ruler of a former State or his successor under any  
agreement for the time being inforce between the "[Federal]  
Government and such Ruler or his successor, shall, if such State  
has been incorporated into the Province of \*[Balochistan] be  
charged on the Provincial Consolidated Fund and be re-  
imbursed to the °[Federal) Government out of the said Fund,  
and any such sum re-imbursed to the '[Federal) Government
