WHEREAS it is expedient further to amend the
Baluchistan Sea Fisheries Ordinance, 1971, in the

“ manner hereinafter appearing ..

It is hereby enacted as follows:-

1. (1) This Act may be called the Baluchistan Sea
Fisheries (Amendment) Act, 1986.

(2) It shall come into force at once and shall be
deemed to have taken effect on the 11th day of Sep-
tember, 1972.

2. In the Baluchistan: Sea Fisheries Ordinance, 1971,
hereinafter referred to as the said Ordinance, in clause
(f) of section 2, after the. word "includes" the words
"a trawler and" shall be inserted.

3. In the said Ordinance, the existing section 3,
shall be numbered as sub-section (1) of that section
and after sub-section (1), as so numbered, the follow-
ing new sub-section shall be added:-

"(2)No person shall be allowed tofish with encircling
net or improvised purse seine net locally called
"wire net" or "gujja" or ring net & bottom trawls

locally called "trawls" or "gujja" in the close bays of Sonmiani and Kalmat and twelve nautical miles from shore along the yest of Baluchistan coast."

4. In the said Ordinance, in section 9, the full stop appearing at the end shall be substituted by a colon and thereafter the following norte shall be added, namely: -

"Provided that the contravention of section 3, shall be punishable with imprisonment of either description for a term which may extend to three years, or with fine which may extend to five thousand rupees, or with both, and the fishing craft shall be liable to confiscation."

5. .In the said Ordinance. after section 19, the following new section shall be added, namely:-

"19-A. Any thing done, action taken, obligation, liability, penalty or punishment incurred, or proceedings commenced after the lapse of the Baluchistan

Sea Fisheries (Amendment) Ordinance, 1972 (XI of 1972), under the provisions of the said Ordinance shall be deemed to have been properly and validly done, taken, incurred or commenced, as the case may be, as if this Act was in force on the' day on which anything was done, action taken, obligation, liability, penalty or punishment incurred, proceedings commenced."
