WHEREAS it is expedient further to amend  
the Baluchistan Board of Intermediate and Secondary  
Education Ordinance, 1977, for the purpose hereinafter  
appearilg: :

NOW, THEREFORE, in exercise of the  
Powers conferred by 'Article 128 of the Constitution,  
Tead with Article 2 of the PproVisional Constitititcn  
Order, 1981 (C. M. L. A. Order No. 1 of 181), the  
Governor of Baluchistan is pleased to make and Pro-  
mulgate the following Ordinatce:-

ve (1) This Ordinance may be called the Baluchistan  
Board of Intermediate and Secondary Education  
(Amendment) Ordinance, 1984.

(2) It shall come into force at once.

2. In the Baluchistan Board of Intermediate and  
Secondary Education Ordinance, 1977, in clause (iii) of  
sub-section (1) of section 8, the full stop occurring at  
the end shall be substituted by a colon and thercafter

the following ProViso shall be added, namely:-
