No. PAB/Legis; V(09)/2020, The Balochistan University of Medical and Health Sciences (Amendment) Bill, 2020 (Bill No. 09 of 2020), having been passed by the Provincial Assembly of Balochistan on 26 October, 2020 and assented to by the Governor, Balochistan on 03 November, 2020 is hereby published as an Act of the Balochistan

Provincial Assembly.

to further amend the Bolan University of Medical and [ealth Sciences
Act, 2017 (Act No. VI of 2017)

Preamble. WHEREAS, it is expedient to further amend the Bolan University of Medical and Health Sciences Act, 2017 (Act No. VII of 2017), in the manner hereinbelow appearing:

Short title and = 1. (4) | This Act may be called the Bolan University of Medical and commencement. [ealth Sciences (amendment) Act, 2020.
(2) It shall come into force at once.

Amendment of 2. — In the Bolan University of Medical and Health Science Act, 2017 Section 3, Act (Act VI of 2017), hereafter referred to as the said Act in Section 3, for sub VII of 2017 section (2), (3) and (4), the following shall be substituted:-

"(2) Loralai Medical College Loralai and Jhalawan Medical College Khuzdar shall be the constituent colleges, the Bolan Medical College and its Dental Section Shall be the constituent College of University for the period of two (2) years only.

@) Any teaching institution, medical college, dental college, nursing schools or colleges, paramedical schools or colleges may be affiliated with the University as may be prescribed by the Government.

(4) The teaching hospitals of Loralai Medical College Loralai and Jhalawan Medical College Khuzdar shall be the attached hospitals of the University and the Bolan Medical Complex

In the said Act, for Section 4, the following shall be substituted:-

(1) All properties, rights and interests of whatever kind used, enjoyed, possessed, owned or vested in or held in by the University shall be in ownership of the Government,

(2) All employees serving in Bolan Medical College and its Dental Section and Loralai Medical College Loralai and Jhalawan Medical College Khuzdar in any capacity shall remain Civil Servants and their services shall be governed under Balochistan Civil Servants Act 1974 (Act No. 1X of 1974) and the Rules framed there under.

In the said Act, in section 7, in sub section (1). for the proviso the following shall be substituted :-

"Provided that the policy of admission in the University shall continue until modified by the Senate and policy of admission in the Constituent College (s) shall be made in the manner as before the commencement of this Act."

In the Said Act, in Section 8, for sub section (4) shall be omitted:-

In the said Act, for section 38, the following shall be substituted

-(L) There shall be established a university fund to which shall be credited grants received from the federal and provincial

government and income from fees, charges donations, trusts, bequest, endowments, contributions and grant-in aid from any source.

(2) The funds shall be kept in such custody, form and manner as may be determined by the Authority of the University".

{In the said Act, for section 51, the following shall be substituted:-

The Bolan University of Medical and Health Sciences Ordinance. 2007 (XVII of 2007), is hereby repealed.
