further to amend the Code of Criminal Procedure. 1898.

Preamble. WHEREAS. it is expedient further to amend the Code of Criminal
Procedure. 1898 (Act V of 1898) for the purpose hereinafter appearing:

AND WHEREAS, the Governor of Balochistan is satisfied that

NOW THEREFORE, in pursuance of Article 4 of the Provisional Constitution (Amendment) Order. 1999 (Chief Executive's Order No. 9 of 1999), and in exercise of all powers enabling him in that behalf. the Governor of Balochistan is pleased to make and promulgate the following Ordinance:-

Short title. I. (1) This Ordinance may be called the Code of Criminal Procedure (Balochistan Amendment) Ordinance, 2001. commencement,

(a) It shall come into force on the 14th day of August, 2001,

(b) It shall extend only to "B" areas of Balochistan, Amendment of In the Code of Criminal Procedure. 1898, hereinafter referred to as Section 62. the said Code. in section 62. for the words "District Superintendent of Act V of 1898 Police". the words "District Administrative Officer" shall be substituted.
