WHEREAS, it is expedient to further ame
Penal Code, 1860 (Act XLV of 1860) an
Criminal Procedure (Act V of 1898), in the manner he
appearing;

AND WHEREAS, the Provincial Assembly is not in session
and circumstances exist which render it necessary to take
immediate action; j

NOW, THEREFORE, in the exercise of the powers conferred
by clause (1) of Article 128 of the Constitution of Islamic
Republic of Pakistan, 1973, the Governor Balochistan is
pleased to make and promulgate the following Ordinance:-

1. This Ordinance may be called the Criminal Laws
(Balochistan Amendment) Ordinance, 2021.
2. In the Pakistan Penal Code,1860 (Act XLV Of 1860), after
section 290, the following new sections shall be inserted, namely:-
“290-A. Public nuisance by stoppage of roads, streets,
thoroughfare and National Highways by means of protest
rallies, processions and sit-in (dharna). A person who
intentionally causes public nuisance by stoppage of roads, streets,
thoroughfare and National Highways by means of protest rallies,
processions and sit-in (dharna) shall be guilty of Public nuisance.

290-B punishment of public nuisance by stoppage of
roads, streets, thoroughfare and National Highways by means

of protest rallies, processions and sit-in (dharna). Whoever is guilty of stoppage of roads, streets, thoroughfare and National Highways by means of protest rallies, processions and sit-in (dharna) shall be punished with simple imprisonment for three months which may extend to six months and fine of Rs.10,000/- (rupees ten thousand only).”.
