WHEREAS it is expedient to make  
Provision for the development and improvement  
of certain areas in Tehsil Hub, District Lasbela,  
providing public amenities like parks, garcers and  
tourist resorts;

AND WHEREAS the Governor is say; d  
that circumstances exist which rendcr it' necessary  
to take immediate action;

; NOW, THEREFORE, in cxercise of the  
powers conferred by Article 128 of .the Consti-  
tution, read with Artiele 2 of the Provisional  
Constitution Order, 198], (C.M.L.A. Order No. 1  
of 1981), the Governor of' Baluchistan is pleased  
to make and promulgat2 the following Ordinance :-

1. (1) This Ordinance may be called the Hub  
Dam Area Development Ordinance, 1984.

\_, (2) It extends to whole of Tehsil Hub,  
District Lasbela.

(3) It shall come into force at once.

2. In this Ordinance, unless tkere 's anything —  
repugnant in the subject or context :-

(a) "Authority' means an Auttority  
\_ constitutcd under section 3;

(b) "Committee" means Hub Lake Deve-  
opment Committee constitutcd by the  
Ministry of Tourism, Culture and  
Sports, Government of Pakistan;

(c) "Government" means Government of  
Baluchistan;

(d) "Notifisd ara" means the area  
comprising Hub Lake, Hub dam and  
the land within one mile- radius. 'of

the lake, situated in the': Province 'of  
Baluchistan.

3. The Government may, by notification, appoint any body corporate, local Council, Government functionary, Organisation or committee to act as Authority for the notified area for the purposes of this Ordinance. .

4. The Authority shall perform such functions and exercise such powers as may be specified by the Government from time to time for development of notified area for the purpose of Providing public amenities and tourist resorts,

5. No person or body of persons shall construct any building or undertake development activity of any kind in notified area without prior written approval of the Authority,

6. Whoever contravenes the provisions of Section 5 or of any rules made under this Ordinance shall be punished \_ with simple imprisonment for a term not exceeding six months or with fine, or both.

7. No suit or legal proceedings shall lie against Government or the Authority in respect of any thing done or intended to be done in good faith under this Ordinance.

8. The Government may make rules for the Purpose of giving effect to the provisions of this Ordinance.
