(Balochistan Ordinance V of 2000)

An Ordinance to amend the Land Acquisition Act, 1894,
in its application to the Province of Balochistan.

WHEREAS it is expedient to amend the Land Acquisition
Act 1894, in its application to the Province of Balochistan, in the
manner hereinafter appearing;

AND WEREAS the Provincial Assembly of Balochistan
stand suspended in pursuance of proclamation of Emergency of
the fourteenth day of October, 1999, and the Governor of
Balochistan is satisfied that circumstances exist which render it
necessary to take immediate action;

NOW THEREFORE, in pursuance of Article 4 of the
Provisional Constitution (Amendment) Order, 1999, and in
exercise of all powers enabling him in that behalf, the Governor
of Balochistan on the instructions of Chief Executive of Pakistan
is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Land Acquisition
(Balochistan Amendment) Ordinance, 2000.

(2) It shall come into force at once.

2. In the Land Acquisition Act, 1894, in its application to the
Province of Balochistan, hereinafter referred to as the said Act, in
sub section (3) of Section 18, for the words "the Provincial
Government", the words and commas "the Federal Government,
the Provincial Government, a Company or a local authority, as the
case may be," shall be substituted.

3. In the said Act, in clause (c) of section 20, for the words “and the Department of Government”, the words and comma “the Federal Government, or the Provincial Government” shall be substituted.

4. In the said Act, in Section 22-A, for the words and comma “the Provincial Government”, the words “the Federal Government or the Provincial Government”, shall be substituted.

Being an Ordinance made by Governor of Balochistan under the Provisional Constitution (Amendment) Order, 1999 (Chief Executive Order 9 of 1999); protected first under Article 270-AA [as amended vide Constitution (Seventh Amendment) Act, 2003]; and later declared continue in force by clause (2) of Article 270-AA [as amended vide Constitution (Eighteenth Amendment) Act, 2010 (Act X of 2010)], of the Constitution of Islamic Republic of Pakistan, 1974.

5. In the said Act, in clauses (a) and (b) sub section (1) of section 31, for the words "the Provincial Government" wherever occurring, the words and "the Federal Government or the Provincial Government, as the case may be", shall be substituted.

6. In the said Act, in sub section (2) of section 50, the colon appearing at the end shall be replaced by the full stop and thereafter the proviso shall be deleted.
