ORDINANCE  
to amend the Land Acquisition Act, 1894, in its application to  
the Province of Balochistan

Preamble. WHEREAS it is expedient to amend the Land Acquisition  
Act, 1894, in its application to the Province of Balochistan, in the  
manner hereinafter appearing;

AND WHEREAS the Provincial Assembly of Balochistan  
stand suspended in pursuance of proclamation of Emergency of the  
fourteenth day of October, 1999, and the Governor of Balochistan is  
satisfied that circumstances exist which render it necessary to take

° immediate action;

NOW THEREFORE, in pursuance of Article 4 of the  
Provisional Constitution ( Amendment ) Order, 1999, and in exercise of  
all powers enabling him in that behalf, the Governor of Balochistan on  
the instructions of Chief Executive of Pakistan is pleased to make and

promulgate the following Ordinance:-

Short title and 5 (1) This Ordinance may be called the Land Acquisition  
commencement. (Balochistan Amendment) Ordinance, 2000.

(2) It shall come into force at once.

Amendment of 2: In the Land Acquisition Act, 1894, in its application to the  
Province of Balochistan, hereinafter referred to as the said Act, in sub  
AES section (3) of section 18, for the words "the Provincial Government",  
the words and commas "the Federal Government, the Provincial  
Government, a Company or a local authority, as the case may be," shall  
be substituted,

Amendment of 3. In the said Act, in clause (c) of section 20, for the words "and  
an 20 of Act the Department of Government", the words and comma "the Federal  
HOLA: Government, or the Provincial Government" shall be substituted.

Amendment of 4. In the said Act, in section 22-A, for the words and comma "the  
pies oeny of Provincial Government", the words "the Federal Government or the  
nae \* Provincial Government", shall be substituted

Amendment of 5. In the said Act, in clauses (a) and (b) of sub section (1) of  
section 31 of Act section 31, for the words "the Provincial Government" wherever  
eee IO: occurring, the words and "the Federal Government or the Provincial  
Government, as the case may be", shall be substituted

Amendment of 6. In the said Act, in sub section (2) of section 50, the colon  
section 50 ActX appearing at the end shall be replaced by the full stop and thereafter the  
FEDS. proviso shall be deleted.
