An Ordinance further to amend the Land Acquisition  
Act, 1894, in its application to the Province of \*[Balochistan'].

Preamble. WHEREAS it is expedient further to amend the Land  
Acquisition Act, 1894, in its application to the Province of  
?[Balochistan], in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly of West  
Pakistan is not in session, and the Governor of West Pakistan is  
satisfied that circumstances exist which render immediate  
legislation necessary;

NOW, THEREFORE, in pursuance of the powers  
conferred on him by clause (1) of Article 79 of the  
Constitution', the Governor of West Pakistan is pleased to make  
and promulgate the following Ordinance:—

Short title, extent 1. () This Ordinance may be called the Land  
and Acquisition (West Pakistan Amendment) Ordinance, 1965:—

t. (2) It shall come into force at once.

(3) It shall extend to the whole of the Province of  
?[Balochistan], except the Tribal Areas.

Amendment of 2. In Section 17 of the Land Acquisition Act, 1894, in its

(c) in sub-section (4) for the words "in the case of  
any land to which", the words "in case where"  
shall be substituted.

3. In section 40 of the said Act, in sub-section (1), after

clause (a) the following new clause shall be inserted:—

"(aa)

that such acquisition is needed for the  
construction of some building or work for a  
company which is engaged or is taking steps for  
engaging itself in any industry or work which is  
for a public purpose, or".

4. In section 41 of the said Act, for the words, brackets and  
letters "mentioned in clauses (a) or (b)", the words, brackets and  
letters "referred to in clause (a) or clause (aa) or clause (b)"  
shall be substituted.
