Whereas it is expedient to amend the Land Reforms  
(Baluchistan Pat Feeder Canal) Regulation, 1972, in the  
manner hereinafter appearing;

It is hereby enacted as follows :—

1. (1) This Act may be called the Land Reforms (Baluchistan Amendment) Act, 1974.

(2) It shall come into force at once,

2. In the Land Reforms (Baluchistan Pat Feeder Canal) Regulation, 1972, hereinafter referred to as the Regulation, in Paragraph 2, after clause (d), the following new clause shall be inserted, namely :—

“(d) ‘‘Land Reforms Officer’’ means an officer appointed as such by the Provincial Government;”.

3. After paragraph 6 of the Regulation, the following new paragraph shall be inserted, namely :—

“6A. Exercise of powers by Land Reforms Officer—  
The Provincial Government may direct that all or any Powers exercisable by the Board of Revenue may be exercised by the Land Reforms Officer specially appointed by the Provincial Government.”.

4. In paragraph 7 of the Regulation —

(a) in sub-paragraph (1),—

(i) for the words “apply to the Deputy Commis-

sioner within whose district such land is situated” the words “apply to the Land Reforms Officer” shall be substituted; and

(ii) after sub-paragraph (1) amended as aforesaid, the following new sub-paragraph shall be inserted, namely :—

“(1A) An application made to the Deputy Commissioner before the coming into force of the Land Reforms (Baluchistan Amendment) Ordinance, 1973, (Baluchistan Ordinance No. VII of 1973), shall stand transferred to the Land Reforms Officer.”; and

in sub-paragraphs (2), (3), (4), (5) and (6),—

© for purposes Es Dewets Coninketonse the words

“Land Reforms Officer” shall be substituted,
