A Regulation to apply the Minimum Wages Ordinance,
1961 (Ordinance XXXIX of 1961), to the Tribal Areas of the
Province of Balochistan.

Preamble. WHEREAS it is expedient to apply the provisions of the
3Minimum Wages Ordinance, 1961 (Ordinance XXXIX of
1961), to the Tribal Areas of the Province of Balochistan:

NOW, THEREFORE, in exercise of the powers
conferred upon him by clause (3) of Article 261 of the Interim
Constitution of the Islamic Republic of Pakistan, the Governor
of Balochistan, with the prior approval of the President, is
pleased to make and promulgate the following Regulation,

namely: —

Short title and 1. () This Regulation may be called the Minimum
commencemen Wages Ordinance (Application to the Tribal Areas of
t Balochistan) Regulation, 1972.

(2) It extends to the whole of the Tribal Areas of the
Province of Balochistan.

(3) It shall come into force at once.

Application of 2. The provisions of the Minimum Wages Ordinance, 1961
Minimum (Ordinance XXXIX of 1961), and the rules made thereunder
Wages shall apply to the whole of the Tribal Areas of the Province of

Ordinance,
1961, to the
Tribal Areas of
Balochistan.

Balochistan as they apply to the other areas of the Province.
