An Ordinance to extend the Prevention of Corruption
Act, 1947, to the whole of the Province of *[Balochistan'].

WHEREAS it is expedient to extend the Prevention of
Corruption Act, 1947, to the whole of the Province of
3[Balochistan] in the manner hereinafter appearing;

Now, THEREFORE, in pursuance of the Presidential
Proclamation of the seventh day of October, 1958, and in
exercise of all powers enabling him in that behalf the Governor
of West Pakistan is pleased to make and promulgate the
following Ordinance:—

1. This Ordinance may be called the Prevention of
Corruption Act (West Pakistan? Extension) Ordinance, 1958.
2. The Prevention of Corruption Act, 1947 (hereinafter
called the said Act), shall extend to the whole of the Province of
3[Balochistan].
3. In the said Act in its application to the Districts of
Kalat, Kharan, Mekran and LasBella reference to any provision
of the Pakistan Penal Code? or the Code of Criminal Procedure,
1898°, shall as for as possible, be deemed to be reference to the
corresponding provisions of the Tazirat-e-Kalat' and Zabata-e-
Faujdari Kalat®, as the case may be.

4. The Bahawalpur Prevention of Corruption Act, 1950, is hereby repealed.

This Ord., which amended and extended Act II of 1947 to the whole of the Province of W.P. was promulgated by the Governor on 19% December, 1958; published in the W.P. Gazette (Extraordinary), dated 20 December, 1958, pages 1713-14; saved and given permanent effect by Article 225 of the Constitution of the Islamic Republic of Pakistan (1962).
