WHEREAS it is expedient to amend the Provincial Assembly 'of Baluchistan Privileges Act 1975 (Act No. VI of 1975) for the purposes hereinafter appearing;

i AND WHEREAS the Governor. is satisfied that circumstances exist which render it necessary to take immediate action;

NOW THEREFORE, in pursuance of the Proclamation of the 5th day of July 1977, read with the Laws (Continuance in Force) Order 1977 (CMLA Order No. 1 of 1977) and in exercise of all powers enabling him in that behalf, the Governor is pleased to make and promulgate the following Ordinance:— . ra

1. Short title and commencement.

(1) This Ordinance may be called the Provincial Assembly cf , Baluchistan Privileges (Amendment) Ordinance 1978. ,

(2) It shall come into force at once.

2. Anmtendment of Section 4 of Baluchistan Act-No. VI of 1975,

In section 4 of the Provincial Assembly of Baluchistan Privileges Act 1975 (Act No. VI of 1975), hereinafter called the said Act,- ;

(i) in sub-section (i),-

(a) the words "or Election Tribunal" shall be omitted and;

(b) for the comma and words, "Commission or Tribunal" the words 'or Commission" shall be substituted;

(ii) in sub-section (2), for clause (a) the following shall be substituted, namely :— 2

(a) 'applying to any Member detained, under any such law as is referred to therein-

(i) at any time during the period commencing on the fifteefitti day next after the conslusion of a session of the Assembly and ending on the fifteenthday before the commencement of the next session; or

(ii) for reasons of State connected with defence, external affairs or the security of Pakistan or any part thereof; or"

3. Amendment of section 5 of Baluchistan Act No. VI of 1975.

In section 5 of the said Act,-

(a) in sub-section (1),-

(i) the words "or Election Tribunal" shall be omitted; and

(ii) for the comma and words "Commission or Tribunal"

the words "or Commission" shall be substituted; and

(b) in sub-section (2),-

(i) the words "or Election Tribunal" shall be omitted; and

(ii) for the comma and words, "Commission or Tribunal"

the words "or Commission" shall be substituted.
