Whereas it .is expedient to amend the Provincial
Assembly of Balichistan-Privileges Act, 1973, in the manner here-
inafter mentioned;

It is hereby enacted as follows:--

1. (1) This Act may be called the Provincial Assembly of
Baluchistan Privileges (Amendment) Act, 1975.

(2) It shall come into force at once.

2. In the Provincial Assembly of Baluchistan Privileges Act, 1973

(Baluchistan Act No, VII of 1973) after section 10, the following
new section shall be added, namely :—

“10-A Prohibition to carry arms in the Assembly.
ee,

(1) Whoever carries any ‘fire-arms of any description or
knives, lathies, sticks, any explosive or corrosive substance alld
any weapon of offence, within the precincts of the Assembly
shall be liable to punishment with imprisonment of either des-
cription, which may extend to six months or with fine which may
extend to one thousand rupees or With both,

(2) The Speaker may direct the Sergeant-at Arms to take
appropriate Measures, On discovery of any such material as des-
cribed in sub-section (1) above, within the precincts of the
Assembly as defined in clause (pp) of sub-rule (1) of Rule 2 of the
Provincial Assembly of Baluchistan Rules of Procedure and Con-
duct of Business, 1974,”.
