to provide for the appointment of Provincial Law Officers.

Preamble Whereas it is expedient to provide for appointment of provincial Law Officers and to confer on them the tight of audience in all Courts in Pakistan, " in the manner hereinafter appearing:

AND WHEREAS the provincial Assembly of Balochistan stand suspended in pursuance of the proclamation of Emergency of the fourteenth day of October, 1999, and the Governor of Balochistan is satisfied that circumstances exist which render it necessary to take immediate action;

NOW THEREF, 'pursuance of Article 4 of the provisional Constitution (Amendment) aut 1999 (Chief Executive's Order No. 9 of 1999). and in exercise' of afl powers. enabling him in that behalf , the Governor of Balochistan is pleased, to make, and a the following ordinance:-

(2) It shall come into force at once.

2, In this Ordinance, unléss there is any thing repugnant in the subject or content;

(a) "Provincial Law Officers" means the Additional Advocate General and Assistant Advocate General;

(b) "Court" means Supreme Court of Pakistan High Courts Federal Shariat Court, Service Tribunal and Election Tribunals;

(c) "Governor" means the Governor of Relies

(d) "Government" means the Government of Balochistan:

(e) "Rules" means the rules made under this Ordinance;

(f) "Department" means the law Department.

EM (1) The Governor may appoint one or more Additional Advocate

General and Assistant Advocate General as he may consider necessary.

(2) A person appointed under sub-section (1) shall hold office during the pleasure of the Governor and shall receive such remuneration and shall be subject to such conditions as may be determined by the Rules made under this Ordinance:

4. No person shall be appointed under sub-section (1) of section 3, unless:

fa) in case of an Additional Advocate General he is qualified for appointment' as Judge of the High Court, or he has minimum + standing of.3 Years as Assistant Advocaté General.
