1. (1) This Act may be called the Provincial Motor Vehicles
(Amendment) Act, 1995.

(2) It shall come into force at once. ;

2. In the first and second column of the Sixth Schedule to the
Provincial Motor Vehicles Ordinance, 1965,-

(a) for the word and letters "Kachhi.....KI",
the words and letters "Jhal Magsi.....Jhal Magsi" shall be
substituted.

(b) for the word and letters" Tamboo.....TU",
the words and letters "Nasirabad..... ND" shall be
substituted.

(c) for the word and letters"Turbat.....TT",
the word and letters "Kech..... KC" shall be substituted.

(d) after the word and letters "Nasirabad.....ND", as so
substituted, the following new words and letters shall be
added, namely:-

"Bolan hacs BLN
Mastung niin MG
Awaran ns AN
Killa Abdullah ks KA".

3, The Provincial Motor Vehicles (Amendment) Ordinance, 1994

(VII of 1994), is hereby repealed. :
