NOW, THEREFORE, in exercise of the powers conferred by Article 128 of the Constitution of Islamic Republic of Pakistan, the Governor of Balochistan:ig pleased to make and promulgate the following Ordinance :--

L (1) This Ordinance may 'be cafiled the Provincial Motor Vehicles (Amendment) Ordinance, 1993.

(2) It shall come into force at once.

2. In the first and second column of the Sixth Schedule to the Provincial Motor Vehicles Ordinance, 1965,-

(a) for the word and letter "Kachhi..KI" the word and letter

"Shal Magsi..Jhal Magsi" shall be substituted.

(b) for the word and letters "Tamboo,,TU" the word and letter "Nasirabad..ND" shall be substituted.

(c) after the word and letter "Nasirabad..ND" as so substituted, the following new words and letters shall be

added, namely :--

"Bolan BLN

'Mastung MG

Awaran AN"
